**Terms and conditions:-**

- 1.. The project activities are being implemented in Kamareddy, Siddpet and Mahabubnagar. Hence the candidate should stay and work at these places and as per the orders of Director, IIOR.
2. The above position is purely temporary and co-terminus with the Project and also subject to the satisfactory performance of the incumbent. There is no provision of re engagement after termination of the project. The selected candidate shall not claim for regular appointment at this Institute as the fellowship.
3. Age limit as on 1.7.2021 : for Data Entry Operator post is 35 years for Men and 40 years for women. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India Rules applicable to the external funded project.
