- 1.. Place of posting is ICAR - IIOR, Hyderabad. Work place may be at any Research Farm of IIOR, Hyd. (Rajendranagar /Narkhoda /ICRISAT, Hyderabad).
2. The above position is purely temporary and co-terminus with the Project and also subject to the satisfactory performance of the incumbent. There is no provision of re engagement after termination of the project. The selected candidate shall not claim for regular appointment at this Institute as the fellowship.
3. Age limit as on 1.11.2021 : for Sr. Research Fellow post is 35 years for Men and 40 years for women. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India Rules applicable to the external funded project.
