- 1. Place of posting is ICAR IIOR, Hyderabad. Work place may be at any place in Telangana
- 2. The above position is purely temporary on contractual basis for a period of six months initially which is likely to be extended till the end of the project up to 31.3.2022 (project likely to be extended) based on satisfactory performance of the incumbent or until further orders whichever is earlier. There is no provision of re-engagement after termination of the project. The selected candidate shall not claim for regular appointment at this institute as the post is co-terminus with the project.
- 3. Age limit as on 1.2.2022: Minimum of 21 years and maximum age limit is 35 years for men and 40 years as per rules. Relaxation in upper age limit is permissible in case of SC/ST/OBC/PH candidates as per Govt. of India Rules applicable to the external funded project.
