- 4. The maximum age limit for appointment on deputation/deputation (including short term contract) shall not exceeding fifty-six years (56) on the closing date of receipt of application.

The official, who initially comes on deputation and considered suitable for the post, may be permanently absorbed by the appointing authority, if no incumbent is available in the feeder cadre, in accordance with guidelines of DoP&T/GOI and the parent Department agrees to the proposal of permanent absorption.
