Sub: Non-receipt of AUCs in respect of TSP under AICRP (Sesame & Niger) for 2012-13 – regarding.

Sir,

I am directed to inform you that the AUC (Audit Utilizations Certification) for the year 2012-13 for the funds released by this Directorate to centres under your SAUs pertaining to TSP (Tribal Sub-Project) under AICRP (Sesame & Niger) have not been received so far. The Audit party in their recent report has taken the issue very seriously and sought a copy of AUCs immediately. Further, ICAR has also directed us to strictly adhere to the guidelines on release as per GFR, which means releases should be made only on receipt of AUC for the releases made in the previous year. Hence, due to non-receipt of AUCs, further release of approved grants for the current financial year 2013-14 cannot be made.

In view of the above, you are requested to personally monitor the issue and arrange to send the requisite AUCs for TSP under AICRP (Sesame & Niger) for the year 2012-13 duly signed by Statutory Auditor **by return Fax (No.040-24017969)** followed by post, failing which the funds may left unutilized and the matter would be brought to the notice of the concerned at ICAR and further release will be withheld.


