

2. The candidates must be initially appointed as Technical Assistant (T-3)/Category-II under the Functional Group of Field/Farm may send their applications through proper channel in the enclosed proforma (as format of application) to the undersigned. The candidate must possess essential qualification i.e. Bachelor Degree in Agriculture or equivalent qualifications from a recognized University. Under the Functional Group of Press & Editorial for the post of Hindi Assistant/Translator, the candidate must possess Bachelor's Degree of a recognized University in Hindi with English as a compulsory or elective subject or the revised qualifications amended by the Council vide their letter No.TS/5(2)/2011-Estt.IV, dated 06.05.2014. **The last date of receipt of applications is 20.02.2021.** Application's received after the last date or otherwise incomplete are not likely to be considered. 3. The Candidate who becomes due for promotion to the grade of STO(T-6) on any date before the date of recommendation by the Selection Committee will not be considered.

4. In case of applications received in large numbers, criteria shall be formulated for selection of the candidate for the above said vacancies in different functional groups.
5. The above inter-institutional transfer will be regulated as per Council's instructions vide F.No.TS-19(01)/2002-Estt.IV, dated 19.03.2020.
